- **You may submit your appeal from 1st March 2019 onwards so that it is lodged and acknowledged.** It is recommended that **you submit any supporting documentation of your case at this time if you wish if you have collated this in advance.** Alternatively, if there is any supplementary paperwork or evidence you would like the appeal panel members to have time to read in advance of your son's hearing, it is advisable to submit these to Poole Grammar School by **9.00am on Wednesday 17th April 2019 in order to prepare and distribute the appeal packs to the panel.** Any documents delivered after the deadline may not be considered.
- **Please note that we can only accept appeals electronically if they are under 10MB. If your son's appeal pack is over this size, please print and hand in to the school reception.**
- **Please put your child's name on all papers submitted and insert page numbers into accompanying documents if possible for example 5/20 following this appeal form.**
- If you wish to send in any documents in support of your case, and you would like us to return them, please state this clearly – otherwise they will be retained by the Clerk and eventually destroyed.
- Please be advised that in order to be fair and remain impartial, we are unable to discuss details of individual cases. If you require any information or clarification regarding the Appeals process please contact Mrs Claire Collins or Democratic Services at the Borough of Poole.
- The Stage 1 hearing will be held at Poole Grammar School at 4pm on Tuesday 7th May 2019.
- The Stage two hearings will be held from Wednesday 8th May to Wednesday 15th May 2019 at Poole Grammar School.
- The date and time of the Appeal Hearing will be confirmed in writing to you by Democratic Services at the Borough of Poole.
